DURING FY20, TREES ATLANTA VOLUNTEERS PLANTED 4,945 NEIGHBORHOODS TREES (6-8 FT TALL). TREES ATLANTA'S URBAN TREE PROGRAM PLANTED 391 15-FOOT TALL TREES IN METRO ATLANTA SIDEWALKS, PUBLIC SPACES AND ON PRIVATE COMMERCIAL PROPERTY DURING FY20.
