IN THE 2020/2021 PLANTING SEASON, TREES ATLANTA PLANTED AND CARED FOR 6,608 TREES IN METRO ATLANTA WITH THE HELP OF VOLUNTEERS AND CONTRACTORS. DURING FY21, TREES ATLANTA VOLUNTEERS PLANTED 4,564 NEIGHBORHOODS TREES (6-8 FT. TALL). TREES ATLANTA'S URBAN TREES PROGRAM PLANTED 455 15-FOOT TALL TREES IN METRO ATLANTA SIDEWALKS, PUBLIC SPACES AND ON PRIVATE COMMERCIAL PROPERTY.
